



PHOTOGRAPH VERIFICATION FORM

Applicants registering with the Natural Resources Canada (NRCan) National Non-Destructive Testing Certification Body (NDTCB) **for the first time** must submit a completed "Photograph Verification Form" with two (2) original (hardcopy) passport photographs. Electronic photographs will not be accepted.

The passport photographs must:

- Measure 5 cm wide X 7 cm high (2 inches wide X 2-3/4 inches high);
- Be taken by a commercial photographer and be professionally printed on photographic paper;
- Be clear, sharp, in focus, and in full colour;
- Be taken straight on with the face and shoulders centered and squared to the camera;
- Reflect the candidate's current appearance (taken within the last twelve (12) months);
- Have the candidate's complete name and the date the photograph was taken on the back of the photograph.

Self-taken and/or self-printed photographs and non-passport photographs will not be accepted. The NRCan NDTCB may request additional photographs at any time if previously submitted photographs are deemed unacceptable.
